



## FESTIVAL POLICY

### Registration

To register the participant must :

1. Complete and submit online the Registration Form by following the link below

2. Return by email this document completed, signed and dated
3. Make the payment of the selected fees. The registration will be confirmed only once payment is received

Registrations are entered by arrival order. Therefore, if one of the training is full your name will be added to the waiting list.

### Training Schedule

The festival will be allowed to make some modification in classes when an adjustment is needed due to the participants level. The festival will also be allowed to evaluate participants to help them move to a different class level if required.

### Payment

Payment can be done online via Paypal, by bank transfer or by cheque (French Only)

### Cancellation

Payments are not refundable. Reimbursement will be made only based on the following situations

#### Cancellation due to the festival

The festival will be allowed to cancel some trainings when participants number is not sufficient. If an equivalent training cannot be offered to the participant, the festival will proceed to a full refund.

#### Cancellation due to covid19 pandemic

If the festival must be canceled due to current or future decisions made by the French authorities (government, city council, etc), such as :

- Traffic restrictions (unavailable airplane, train, coaches, etc)
- Administrative closures of businesses, public buildings and accommodations
- Measures to contain or limit public gatherings
- Or any measure that does not allow the contract to be performed normally

In that case, the festival would refund training fees to participants expect a €30 fee to cover the registration work. However, participants who wish to make a donation to the festival will be allowed to do so.

#### Cancellation due to participant

The participant will be allowed to require a fee refund at the latest 1 month and half before the festival opening, which means not after June 6th at midnight. The festival will then reimburse the fees to the participants except a €50 fee to cover registration work and cancellation costs. If you do not require the refund before June 6th, no refund will be possible.

Apart from the situations above, refund request by participants will not be eligible. However, we are open to evaluate each personal situation on a case-by-case basis to provide you with a specific answer regarding reimbursement. You can contact us by email about that matter.

## **Accident**

By registering via the online registration form, the participant agrees to transport his/her person or child to the nearest hospital in of accident. The participants also gives his/her consent for the hospital to undertake all medical procedures required for his/her health safety or the health safety or her/his child.

The festival responsibility or the teachers responsibility cannot be engaged in case of accident that would cause injuries or material damages to the participant, during training as well as during all their trips outside the festival.

The participant agrees to complete a medical consent form confirming that they do not have any health issues that would stop them to take part in the festival activities (please, complete the last page of this document).

## **Photos / Videos Consent**

By registering, the participant, or his/her child:

- Accept to appear in photos and videos taken during the 11th Festival Les Rencontres de Danse Aérienne which take place at La Volière (Saint-Nazaire) from July 18th to 30th, 2021
- Authorizes the festival to broadcast, in whole or in part, with no border or duration limits, the images or recordings made during the festival for the promotion of the festival

This authorization includes in particular the right to reproduce and communicate this material to the public, by television broadcasting, by internet (site, social networks ...) and in the press.

A poster mentioning the potential shootings will be display on site, before each shooting, participants will be aware vocally and can then choose to remain on the pictures and videos or to leave the shooting.

To take photos and videos are prohibited during training to respect the teachers work. We ask you to not take photos/videos if you haven't discussed that matter with the teachers first.

Photos and videos are also prohibited during student presentations and professional shows to respect the artists work. We invite you to respect that rule at all time. We would like to remind you that the festival owns the images and videos that could be taken during the performances. No video of an artist can therefore be made without permission of the artist and of the festival, it should be discussed prior to the performances.

## **Discrimination and Use of equipment**

No discrimination of any kind will be allowed during the festival, our priority is that everybody must feel respected by other participants and teachers.

The consumption of alcohol, tobacco (and other substances) is strictly prohibited inside the festival.

Each participant must comply with a rational use of the place and the equipment available during the activities. These should only be used for their main purpose.

Any offender will be excluded from the activities in question. Equipment that has been damaged due to deliberately inappropriate use will be billed to the offender according to the market rate and the degree of prior use.

## **Valuable Objects**

The festival is not responsible for any loss or theft of personal items left on the premises. We invite you not to bring valuable objects and to take care of your personal items.

## **Insurance**

The festival fees include a membership which offers an insurance at LA MAIF. This insurance will cover participants during training times at the La Volière (Saint Nazaire)

It is up to each participant, to have access to the course, to be in possession of civil liability insurance, as well as an individual insurance certificate covering the damage that he or she could cause to third parties or to the facilities.

### **Covid19 Procedures**

Before the start of the festival, we will send you the covid19 procedures in order to welcome you in a safe space. By participating into the festival you are engaged to respect the procedures.
